Protective Gear: Hard hats and boots required for all classes.

Entry Fees: \$30 per class. Late entries will be \$35 per class.

Reader will be provided unless otherwise indicated.

Non-competing horse: \$20 grounds fee plus office fee.

Registration: Open until full.

Office fee: \$15 each rider/horse pair.

Closing Date: Postmarked 8 days prior to the show.

Refunds: No refunds after closing date unless a veterinarian's certificate is presented.

Stabling: \$30 per overnight, \$25 per day stall

Jump out fee : \$10 for tie to trailer for the day.

Shavings: Available for \$9 per bag.

Camping: \$25/night. RV electrical hook-up included. Water available via hose to campsites.

Riding times: Times will be posted on Facebook or sent via email Thursdays prior to show.

Awards: Ribbons to 6th place. Jr and Sr High Point awards each day for Intro and Training Level and above.

Coggins: Copy of current negative test must be included with entry.

Entry Form: One entry form per day and horse/rider combination. No substitutions of horse or rider. Maximum of 3 rides per entry.

Checks: Make checks payable to Heartland Equestrian Center.
